Circles of Volunteerism in the Podiatric Profession: 2023-2024 Large Organization Snapshot

Statement of Purpose and Literature Review

The *Society of Podiatric Organization Volunteerism* was founded in 2024 to investigate, recognize, encourage and support the concept of volunteerism throughout the podiatric profession [1-4].

The objective of this investigation was to describe a cross-section of large podiatric national organization volunteers during the 2023-2024 academic year. The specific aims were to 1) investigate multi-organization volunteerism, 2) promote collaboration and cooperation between organizations, and 3) provide a visual representation of large podiatric organization volunteerism.

Methodology

Data was collected predominantly from publicly available information published through individual organization newsletters and websites during the 2023-2024 academic year. For the purposes of this investigation we considered "volunteers" as Doctors of Podiatric Medicine identified by the respective organizations as serving as a committee member or as a volunteer. Students and non-DPMs were excluded from the analysis.

Surgery (**ABFAS**), American Board of Podiatric Medicine (**ABPM**), American College of Foot and Ankle Surgeons (**ACFAS**), American Podiatric Medical Association (**APMA**), and the Council on Podiatric Medical Education (**CPME**). For a secondary analysis, we also considered professional service positions to include residency program directors, fellowship program directors, APMA House of Delegates participants, and podiatric medical school faculty. Websites were accessed in September of 2024.




-APMA House of Delegates: Delegate and alternate participants from the 2024 APMA House of Delegates were included.



Results

Discussion

As with any scientific investigation, critical readers are encouraged to review the study design and specific results in order to reach their own independent conclusions, while the following represents our conclusions based on the preceding results. We also never consider data to be definitive, but do think that these results might be worthy of attention and future investigation.

-This investigation aimed to describe volunteerism within large podiatric national organizations during a specific time frame of the 2023-2024 academic year. Our conclusions are intentionally generalized, broad, non-comparative, and supportive of all organizational volunteerism.

- ---**667** individuals were recognized as volunteers by ABFAS, ABPM, ACFAS, APMA and the CPME over this time frame.
- ---116 (17.4%) of these individuals volunteered with >1 large podiatric national organizations over this time frame.
- ---We hope the Venn diagrams and tables help illustrate existing collaboration between organizations, as well as demonstrate opportunities for increased collaboration.
- ---Honestly...we kind of thought it would be cool to try and construct a 5-way Venn diagram.
- -The *Society of Podiatric Organization Volunteerism* particularly recognizes and celebrates the **12** individuals identified as "**All-Star volunteers**" who participated with at least 4 organizations and/or service positions over this time frame.

-There are certainly some limitations to consider with this project:

- ----The term "volunteer" is subjective and likely varies from organization-to-organization. The reporting and recognition of volunteers by individual organizations is also variable. Hopefully these results encourage organizations to evaluate their practices and appropriately recognize their volunteers for their contributions.
- ----This is a cross-section methodology describing a single period of time, and does not demonstrate or describe patterns or trends. However, it is our intention to repeat this project every 2-3 years in order to elucidate potential trends.
- ---There likely are other important national podiatric organizations with volunteers not included here.
